The bill would grant individual traditional leaders sole authority to enterprete and implement customary law.

The bill would also prohibit rural people from opting out of the jurisdictional courts, preventing access to alternative forms of justice and circumventing the authority of the constitution.

The very essence of our democracy is the protection of vulnerable people .this bill if enacted would affectively remove that protection for millions of south Africans, particularly women ,gays, lesbians and transgender people.

The protection of the bill of rights is necessary armour against the traditional authority.

If south Africans keep traditional leaders in a modern democracy,

these figure heads should play a role consistence with the constitution, not one that tampers with our rights.
